Chair Mills called the executive session to order at 8:44 PM.

Chair Mills turned the meeting over to Legal Affairs Subcommittee Chair Hitchcock, who provided an update on negotiations with the WREA and reported on the February 20, 2018 mediation.

8:45 PM Member Michalowski joined the meeting.

Subcommittee Chair Hitchcock reported the two parties have come to tentative agreement on a one year contract (2017-2018), with will provide WREA members with a 1% salary increase for FY18, and on a three year contract (2018 – 2021), with COLAs of 2%/2%/2%. Subcommittee Chair Hitchcock outlined other proposed changes to the teachers' contract. She reported the WREA is scheduled to vote on ratification of the proposed agreements on March 21, 2018. Superintendent McCall reported that members of the WREA executive board are hosting informational meetings at some of the schools, prior to the March 21, 2018 ratification vote.

Subcommittee Chair Hitchcock went on to report that the District is awaiting a response from the Teamsters Union Local 170 (paraprofessionals) on the District's most recent offer, which would include salary increases of 1%/2%/2% for a three year contract. Some discussion ensued.

Subcommittee Chair Hitchcock reported that negotiation sessions with the ABA PAs and the nurses are scheduled during the week of March 19, 2018.
